This Reseller Agreement is between Rasmussen Software, Inc. ("RSI"), an Oregon Corporation, and the Authorized Reseller ("Reseller") to sell RSI products to Reseller clients. This agreement describes the terms and conditions for participation in the Reseller Program. RSI and Reseller are independent parties, and this agreement will not form any partnership.

## Agreement Duration

This agreement will begin upon our acceptance of your signed agreement. Either party may terminate the agreement at any time, with or without cause, by giving the other party written notice of termination.

## Qualification

Reseller must place a minimum of \$400.00 USD (before discounts) with the initial order to register as reseller. You must keep your account balance current (all terms are 30-day net). You agree to work within one or both of the plans outlined below:

1. **Purchase for customer** – Place order via online, phone, fax, or e-mail. Reseller agrees to provide customer information (contact name, company name, mailing address, phone number and/or e-mail address) to RSI for the registration of software when placing order.
2. **Purchase for stock** – Stock CD's at \$2.00 each. Upon sale of product(s), reseller agrees to provide customer information (contact, company name, mailing address and phone number) to RSI for the registration of software.

## Discount Structure

Reseller will receive a 25% discount on all orders, except for updates.
